THEORY 2/3 - CLASS CONTRACT 2019-20

TOPICS COVERED -review of Theory 1, 7th chords, inversions, non-diatonic chords, 4 part harmony, figured bass, cadences, passing dominant chords, modulation, counterpoint, instrument transposition, harmonic analysis, dictation, and score reading.

COURSE OBJECTIVE

- 1) Students learn to accurately count rhythms using the "one,ta,te,ta" system with accurate rhythmic sub-divisions and consistent tempo.
- 2) Using solfeggio syllables with moveable "do", students develop and refine their ability to sing melodies on sight and recognize written and aural pitch/interval relationships.
- 3) Students learn to conduct basic meters while performing the tasks above.
- 4) Students practice ear-training exercises on a regular basis.

ABSENTEEISM

NYC Dept. of Education - excused absences

- 7 Blackout rehearsals and performances

Late from vacation - NO

Leaving early for vacation - NO

New York State Law states that in order for a student to receive high school credit for a course, he or she cannot miss more than 10% of class meetings per semester. 90 days per semester 10% = 9 absences maximum!

Makeup work due to an excused absence - Make-up assignments will only be accepted if a student has an excused absence/illness. A student has the number of days equal to the number of days absent/ill to make up the work for full credit.

All excused notes must be presented at the beginning of class on the day the student returns to school, not weeks later.

Class Participation grade

Students who arrive on time and are prepared to work.

Students can earn up to 20 points per day for punctuality and work ethic

If you are late you lose 10 points

If you act out (behavior) you lose 5 points per instance

Quiz & Exam Makeup

Cutting a quiz or text/exam will result in a zero for that quiz or test.

Failure to perform in a concert or final culminating performance without an excused absence will result in a failing grade.
